We agree that all transactions undertaken by **ACF**, its nominees and/or its sub-agents on behalf of this company are done so subject only to their standard trading conditions receipt of which is hereby acknowledged. We also agree to indemnify **ACF** against all and any claims arising from Customs, GST or Quarantine declarations **ACF** makes on our behalf, and we further indemnify **ACF** against any action, proceedings or penalties levied by the relevant authorities pursuant to, but not limited to the enforcement and applicability of the Customs and Excise Legislation Amendment Act (No. 2) 1989, and other related legislature.

This authorisation supersedes any previous authorisations to clear goods on our behalf.
